

RENEWAL SERVICES PROGRAM

Minnesota Community Care provides assessment and Medication Assistance Treatment (MAT) of opioid use disorders in a community health setting. Our Renewal Services Program is a team-based program for treating substance use disorders through behavioral health therapies in combination with FDA-approved Buprenorphine maintenance treatment (e.g., Suboxone®).

Medical and behavioral health care is available both in the clinic and in collaboration with other providers and clinics. Patients attend visits on a weekly to monthly basis.

We accept Medicare, Medicaid (Medical Assistance), all commercial/private insurances, and offer a sliding fee scale if needed.

Everyone is welcome regardless of ability to pay.

Minnesota Community Care has provided substance use disorder treatment since 2010. In 2019, we began offering a more comprehensive program for those struggling with substance use disorders. Since then, we have grown our program and currently serve more than 150 patients. We have immediate openings available for new patients seeking help.

WHAT IS MEDICATION ASSISTED TREATMENT (MAT)?

MAT is a “whole-patient” approach to the treatment of substance use disorders. FDA-approved medications are used in combination with counseling and behavioral therapies. Buprenorphine and other medication treatments have been shown to significantly reduce the need for inpatient detoxification services.



WHO IS ELIGIBLE?

PEOPLE STRUGGLING WITH OPIOID USE DISORDER ARE ELIGIBLE FOR OUR RENEWAL SERVICES PROGRAM, REGARDLESS OF ABILITY TO PAY. WE ACCEPT MEDICARE, MEDICAID (MEDICAL ASSISTANCE), LL COMMERCIAL / PRIVATE INSURANCES, AND OFFER A SLIDING FEE SCALE, IF NEEDED.
